The tendering process by PFC/ CIL are presently under process and unlikely to fructify by 25.08.2023.


In view of above, the following are approved by the competent authority

- i. The consumers having existing tripartite agreements (TPAs) with the same terms and conditions and rate signed with QCI may be allowed to extend the same for the period upto 03(three) months i.e. upto 25.11.2023 or till the issuance of LOI/ Work Order against the tender of PFC/ CIL , whichever is earlier to take care of sampling continuity.
- ii. QCI can also enter into new tripartite agreement for the willing consumer(s), if any, during the extended period of 03(three) months (i.e. upto 25.11.2023) "

Accordingly, consumers having valid tripartite agreements with QCI as on 25.08.2023 may extend the same for a period upto 03 months (i.e. upto 25.11.2023) with the existing terms and conditions of the tripartite agreement for sampling continuity, if desired. For such extension if desired by the consumer, such consumer shall sign a side agreement for extension for extension period of three months (i.e. upto 25.11.2023) with the existing terms and conditions of the tripartite agreement on or before 25.08.2023.

In view of above, the following are approved by the competent authority:


