NOTIFICATION

New Delhi-2, the 15th Jan. 1958.

S.R.O. 252 : WHEREAS by a notification of the Government of India in the late Ministry of production S.R.O. No. 564 dated the 3rd March, 1956, under sub-section (1) of section 4 of the land described in the Schedule appended to that notification was needed or was likely to be needed for a public purpose, namely, for the prospecting of coal seams for the development of the State Collieries to be worked by the Union of India;

AND WHEREAS the competent authority in pursuance of sub-section (3) of section 28 of the Coal Bearing Areas (Acquisition and Development) Act, 1957, (20 of 1957, read with section 8 of that Act, has made his report to the Central Government;

AND WHEREAS the Central Government, after considering the report, and after consulting the Government of Bihar, is satisfied that —

- (a) the lands measuring 3310.30 bighas described in Schedule A appended hereto and
- (b) the rights to mine, quarry, bore, dig and search for, win, work and carry away minerals in the lands measuring 1372.44 bighas described in Schedule B appended hereto

should be acquired;

NOW, THEREFORE, in exercise of the power conferred by sub-section (1) of section 9 of the Coal Bearing Areas (Acquisition and Development) Act, 1957 (20 of 1957), it is hereby declared that the land measuring 3310.30 bighas described in the said Schedule A and the rights to mine, quarry, bore, dig and search for, win, work and carry away minerals in lands measuring 13.72.44 bighas described in the said Schedule B, are hereby acquired.

The plans of the areas covered by this notification may be inspected in the office of the Deputy Commissioner, Hazaribagh or in the office of the Coal Controller, 1, Council House Street, Calcutta, or in the office of the National Coal Development Corporation (Private) Ltd., (LA Section), Darbhanga House, Ranchi.
