M O T I F I C A T I O N

S.O. 73 whereas by the notification of the Government of India in the Department of Mines and Fuel (Ministry of Steel, Mines and Fuel) S.O. 1761 dated the 18th August, 1958, under sub-section (1) of section 7 of the Coal Bearing Areas (Acquisition and Development) Act, 1957 (20 of 1957), the Central Government gave notice of its intention to acquire the lands in the locality specified in the Schedule appended to that notification;

And whereas no objection was made to the acquisition of the land aforesaid;

And whereas the Central Government, after consulting the Government of Bihar is satisfied that the lands measuring 131.85 acres described in the Schedule appended hereto should be acquired;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 9 of the said Act, the Central Government hereby declares that the lands measuring 131.85 acres described in the said Schedule are hereby acquired.

The plans of the areas covered by this notification may be inspected in the office of the Deputy Commissioner, Hazaribagh (Bihar) or in the office of the Coal Controller, 1, Council House Street, Calcutta, or in the office of the National Coal Development Corporation (I) Ltd., (Revenue Section) Darbhanga House, Ranchi.
